Highway Working Risk Management Services

Introduction

Whether carrying out tasks such as litter picking along dual carriageways, rural and busy urban highways, grass cutting on central reservations or maintaining floral displays on roundabouts, grounds maintenance and street scene workers are increasingly at risk of injury by working on or adjacent to highways.

Health, safety and wellbeing at work is a primary and collective responsibility. Employers are required, so far as is reasonably practicable, to protect the health, safety and wellbeing of all employees and other persons affected by their activities.

Councils' have a duty of care to ensure that employees are kept safe at work and that adequate health and safety actions have been carried out. Working on highways or high speed roads requires compliance with the Health and



Safety at Work Act, the Management of Health and Safety at Work Regulations 1999, the Corporate Manslaughter and Corporate Homicide Act 2007 and other relevant legislation or guidance, such as the Department of Transport Traffic Signs Manual (Chapter 8).

In order to protect workers and meet current legislation Councils' should develop Highways Site Specific Risk Assessments for employees working on or adjacent to the highway. These risk assessments will cover a range of day to day grounds maintenance operations such as grass cutting, hedge cutting, weed spraying, litter picking, road sweeping, maintenance of floral displays and tree & shrub planting. The purpose of these assessments is to identify risk and to propose mitigations specific to each route for working on the highway.

Methodology
